## BOARD MINUTES September 10, 2020

Summarized **MINUTES** from a regular Board of Commissioners meeting of Scott Valley Fire Protection District, Greenview, California. The meeting was held on Thursday September 10, 2020 and was opened at 6:15 p.m. by Chair Larry Alexander. Present were Vice Chair James C. Roseman, and board members Kathleen Williams and Kevin Hullquist, and Administrative Officer Nancy Salucci. Jay Akerman was absent.

A Train the Trainers session sponsored by United Way was presented by Wildfire Behavior Analyst Jay Perkins. Numerous topics of interest were shared with those present including up-dates about Office of Emergency Services (OES) and the urgency to sign-up for Siskiyou County's OES web—Code Red: <a href="https://www.co.siskiyou.ca.us/emergencyservices/page/codered-emergency-alert-system">https://www.co.siskiyou.ca.us/emergencyservices/page/codered-emergency-alert-system</a>. Using the 2018 Camp Fire as an example, Perkins stressed the need to identify and assist vulnerable residents, especially our neighbors, and to recognize that 95% of "first" responders are actually our nearby neighbors. Perkins spoke of how our firefighters can serve as emissaries to disseminate fire safety and prevention information locally. Another valuable Train the Trainers session will be scheduled after fire season.

<u>CalFire Foundation grant</u> We received the grant award approval for \$10,000 for firefighting equipment. Funds are expected to be distributed this month as all paperwork has been completed. Motion to accept the \$10,000 grant from CalFire Foundation: Motion Roseman/2<sup>nd</sup> Williams, 4 ayes, 1 absent. Motion passed.

Cal Fire VFA 50%/50% grant for 2020-21 Approval for \$15,144 funding was received for twelve radios.

Resolution 20-09-10 to accept the funding was passed with 4 aye votes, 1 absent, and no noes.

# Approving the Department of Forestry and Fire Protection Agreement #7FG20116

for services from the date of last signatory on page 1 of the Agreement to June 30, 2021 under the Volunteer Fire Assistance Program of the Cooperative Forestry Assistance Act of 1978.

**BE IT RESOLVED** by the Board of Directors of the Scott Valley Fire Protection District that said Board does hereby approve the Agreement with the California Department of Forestry and Fire Protection dated as of the last signatory date on page 1 of the Agreement, and any amendments thereto. This Agreement provides for an award, during the term of this Agreement, under the Volunteer Fire Assistance Program of the Cooperative Fire Assistance Act of 1978 during the State Fiscal Year 2020-21 up to and no more than the amount of \$15,114.

<u>CalFire VFA 50%/50% grant for 2019-20</u> has been approved by CalFire for payment of \$3,858.21. This grant is for ladder belts and Nomex wildland clothing.

<u>2018-29 annual Smith & Newell CPAs, Audit approval and corrective action plan</u> The Board agreed with the findings of the audit and implemented a corrective action plan to accurately reconcile capital asset accounts.

<u>Insurance renewal: Communicable Disease Exclusion</u> There will be a communicable disease exclusion (i.e. COVID-19) on our next insurance policy renewal.

<u>Chaser Vehicle update</u> The new Ford chaser vehicle (purchase and repairs funded by the Dalmatians) has been insured. A rebuilt engine is presently being installed.

<u>Oral communications, correspondence, continuing/new business</u> Scott River Station (Pastures of Heaven) owners offered \$2500 for the heater. The board gladly accepted their generous offer. The heater was purchased by the Dalmatians, so the proceeds will go to the Dalmatians.
