BOARD MINUTES July 8, 2021

Summarized MINUTES from a regular Board of Commissioners meeting of Scott Valley Fire Protection District, Greenview, California. The meeting was held on Thursday, July 8, 2021, and was opened at 5:00 p.m. by Chair Larry Alexander. Present were board members Kathy Williams, Kevin Hullquist, and Scott Frick, plus Administrative Officer Nancy Salucci and Acting Chief Ben Austin. Commissioner Roseman, Chief Paul Buchter, and Assistant Chief Steve Poling were absent.

Public Report: None

Administrative Officer Salucci

QVIR Memorandum of Understanding (MOU). County Counselor Dana Barton submitted her findings on the QVIR/SVFPD MOU with the opinion that it "would not work" as written. At Counselor Barton's suggestion, QVIR Fire Administrator Veronica Rasmussen will try to obtain a sample of an approved Bureau of Indian Affairs fire protection services and equipment contract template. Further discussion was held over the potential benefits to both QVIR and SVFPD. The Board also discussed the possibility of writing a less formal document akin to an automatic/mutual aid agreement.

Additions/deletions to roster/new firefighter applications Boston Nichols was removed from the roster. Devon Booth was approved by the Board. Albert Buchter, Wayne Drager, and Kim Knox were approved pending completion of vetting process. In processing new applications, Salucci noted that two applicants hold current out-of-state driver's licenses. FASIS explained it makes no difference in our workers' comp coverage whether a member holds an out-of-state license. The Board agreed to modify the Policy and Procedure manual to state that instead of requiring a California driver's license, a "current and valid" license would qualify.

Training/Safety/Injury and Illness Prevention Program monthly report Recent safety focus: Safety reasons for caulking equipment and extreme fire behavior. Auxiliary water tender drivers Administrative Officer Salucci confirmed that auxiliary personnel can be placed on our roster and insurance on a quarterly, not annual, basis and they will operate under the following policy that has been in effect since 2015:

POLICY TITLE: Job Description – Driver / Water Tender Operator POLICY NUMBER: 2306.40 2306.41 Under supervision of the Station Captain and Chief: Acts as a Driver, Water Tender Operator. This position requires a current CDL with applicable endorsements for the apparatus being operated and a valid health certificate as required by the California Vehicle Code. The Driver Operator shall maintain certificates and appropriate driver's licenses and promptly notify the department of any changes in compliance. The Driver Operator is not required to be a frontline Firefighter. This is a support staff position.

Monthly revenue deposits, transfers, approval, and payment of bills: Deposits: \$37,069.53 from the Gold Fire. A \$100.00 donation was received from Gamma Omricon Master. This is a much-appreciated annual donation and was unanimously approved and accepted by the Board.
