BOARD MINUTES August 12, 2021

Summarized MINUTES from a regular Board of Commissioners meeting of Scott Valley Fire Protection District, Greenview, California. The meeting was held on Thursday, August 12, 2021, and was opened at 5:00 p.m. by Chair Larry Alexander. Present were James C. Roseman, Vice Chair and board members Kathy Williams, Kevin Hullquist, and Scott Frick, plus Administrative Officer Nancy Salucci and Acting Chief Steve Poling. Also present was community member Wayne Drager.

Public Report: As a former member of Boulder Creek FPD, SVFPD and Etna FD Chief, Mr. Drager spoke of his concerns about departments participating on out-of-country strike teams to the potential detriment of their local communities.

Acting Chief Steve Poling

Continuing/New business Chief Poling reported that all went well on the Dixie Fire. Former Chief Ben Austin was appointed Acting Chief in Poling's absence. Administrator Salucci reported that Austin was in frequent touch with her. Some equipment issues were noticed and 1530 may need a new gearbox. The new Chaser Rig is numbered 1550. Poling submitted two new applications today.

CLOSED SESSION—PERSONNEL No action taken. Referred to Operations for action. **QVIR Memorandum of Understanding (MOU)**. QVIR Administrator sent a copy of a Bureau of Indian Affairs Memo of Understanding to be used as a sample for a possible agreement between QVIR and SVFPD. The Board instructed Administrator Salucci that it would be up to County Counsel to adapt it to both party's needs.

Additions/deletions to roster/new firefighter applications Kim Knox was added to the roster. Wayne Drager declined. Al Buchter's application is pending. Two new applications were submitted today.

Training/Safety/Injury and Illness Prevention Program monthly report Recent safety focus: Safety vehicle inspections, structure protection safety, and the need to follow fire ground instructions.

Banner Bank up-date signors. The Board agreed to remove Jay Akerman as a signatory on the account, leaving Board members Williams and Hullquist and Administrator Salucci as the three signors on the Banner Bank checking account. Two signatures are required on checks. Motion Hullquist/2nd Roseman, all ayes, passed.

2019-2020 Audit The audit was completed by Smith & Newell CPAs. The Governmental Disclosure Checklist and representation letter were signed. A corrective action plan re capital asset reporting will be completed by next month. Monthly revenue deposits, transfers, approval; payment of bills; strike team payments due/received; IRS penalty levied and appealed. \$927.89 Mary Fire; \$674.83 Meadow Fire. Thus far this fire season SVFPD has billed over \$27,000

to CalFire, OES, and USFS for strike team participation. This is excluding the Dixie fire.

SVFPD has historically made Quarterly IRS deposits. Recently we were penalized for making quarterly deposits instead of monthly deposits. Two appeals are pending. An IRS deposit for July & August (3rd Quarter) is being made as we switch to monthly deposits due to increased strike team participation.
