# SVFPD MINUTES May 12, 2022

Summarized MINUTES from a regular Board of Commissioners meeting of Scott Valley Fire Protection District, Greenview, California. Chair James C. Roseman opened the meeting on Thursday, May 12, 2022. Present were Vice Chair Larry Alexander, Commissioners Kevin Hullquist, Scott Frick and Administrative Officer Salucci. Excused absence Commissioner Williams.

## **Public Report Period None**

Opening bids for sale of engine 1516 At the March and April meetings, Wayne Drager offered to purchase engine 1516 for \$2500 and submitted a written bid. Two additional bids were received from John Berggreen (\$2000) and Clint Jones (\$2100) by mail. These unmarked bids were opened by Administrative Officer Salucci prior to the meeting. No other bids were received. Mr. Drager was the highest bidder and submitted a check for \$2500.00. Because the value of 1516 was below \$5,000, this was not a capital asset sale. Operations personnel will strip the vehicle of all identifying logos, lights, siren, and emergency medical response equipment and make arrangements for the transfer. Mr. Drager was informed that the vehicle is not CARB compliant and it can not be registered in the State of California. Mr. Drager assured us that this would be used solely in the Clarks Creek Neighborhood Watch area.
