## SVFPD MINUTES January 13, 2022

Summarized MINUTES from a regular Board of Commissioners meeting of Scott Valley Fire Protection District, Greenview, California. The meeting opened by Chair Larry Alexander on Thursday, January 13, 2022. Present were Vice Chair James C. Roseman, and Commissioner Kevin Hullquist. Excused absences Commissioners Kathy Williams and Scott Frick. Also present were Chief Paul Buchter, Administrative Officer Salucci, and community member Wayne Drager.

## Public Report Period

Wayne Drager asked the Board to approve selling him SVFPD's Engine 1516 4WD Model 5 that is currently at the Callahan Station. The engine is due to be cycled out of SVFPD's fleet sometime this year. Mr. Drager's intention is to utilize 1516 as a personal wildland fire vehicle to personally protect his and his neighbors' properties. Drager would remove all emergency red lights, strip the vehicle of all professional gear including SCBA's, and repaint it. Per Drager's investigations, the vehicle is worth \$500-\$3500. He offered \$2500. Chief Buchter stated there may be potential liabilities involved. The Board suggested this proposal be referred to County Counsel for advice.

## James C. Roseman, Vice Chair, (Personnel Liaison)

**CLOSED SESSION Personnel** Actions taken in the closed session were salary increases for employees: 25% salary increases for both the Chief and Assistant Chief, bringing the salaries to \$13,000; and salary increase for Administrative Officer of 15% bringing the salary to \$42,866.25. All employees received "Outstanding" reviews. Vice Chair/Personnel Liaison Roseman acknowledged that these salaries are lower than comparable positions throughout the state and county, but it is "a step in the right

direction" towards achieving equity. It was noted that SVFPD is funded primarily by tax dollars, grants, and mutual aid agreements. Working capital revenue varies from year to year and therefore is not sustainable as such. In the event of a loss in revenue, it may become necessary to reduce an employee's compensation and/or work hours as available funding dictates.

## Chief Paul Buchter

**Training/Safety/Injury and Illness prevention Program monthly report**: The COS spring semester training by Mike Wilson just began. The safety focus at a recent class included firefighter health and safety, proper eating, building construction, ladder deployment, structure ventilation reviews, falling and hoisting hazards.

## Additions/deletions to roster/new firefighter applications None.

**Resolution** was passed authorizing Chief Buchter to represent SVFPD with the Siskiyou County Building Department regarding the pending training facility construction plans.

**CalFire Wildland Prevention Grant** Chief Buchter and Charnna Gilmore are collaborating on a grant proposal for strategic placement of water storage tanks throughout the Valley.

**QVIR Memorandum of Understanding (MOU)** The board voted to withdraw from negotiations with QVIR to place a SVFPD engine with personnel at the QVIR fire hall. Motion to terminate negotiations Hullquist/2<sup>nd</sup> Roseman, three ayes, passed. County Counsel will be notified.

## **Continuing/new business**

- Chief Buchter shared his intention to "strongly pursue new hires and develop captains" in the coming months.
- Many people from both Etna and Fort Jones have approached Chief Buchter with requests to reconvene the consolidation meetings. This may involve the creation of a Special Services District.

## Administrative Officer Nancy Salucci

**Monthly revenue deposits, transfers, payment of bills; strike team payments received:** \$301,981.42 from the River Fire Complex and \$44,642.40 from the River Fire Complex at Scott Valley Airport.

Payments still due: Scott Fire, River Fire Complex at Trinity Heliport, KNP Fire (Kings National Park), and Alisal Fire (Santa Barbara County) totalling \$391.661.20.

# SVFPD Minutes January 13, 2022

**Update on transition to hiring outside bookkeeping service.** Following last month's board agreement, Bonnie Jesperson/Bonnie's Bookkeeping Services and SVFPD signed a contract outsourcing payroll and taxes. Services began with the January 2022 payroll.

Transfer: Motion to transfer \$363,000 from State Other into Salaries to cover strike team payments and 4th Quarter IRS and EDD taxes, and to transfer \$50,000 from Appropriations for Contingencies into Special Department Expenses to cover anticipated payments for services and supplies—operating expenses and purchases through end of fiscal year. Motion Roseman/2<sup>nd</sup> Hullquist, all ayes, passed.
