SVFPD MINUTES April 14, 2022

Summarized MINUTES from a regular Board of Commissioners meeting of Scott Valley Fire Protection District, Greenview, California. Chair James C. Roseman opened the meeting on Thursday, April 14, 2022. Present were Vice Chair Larry Alexander, Commissioners Kevin Hullquist, Kathy Williams, and Scott Frick. Also present were Chief Paul Buchter, Assistant Chief Steve Poling, and Administrative Officer Salucci.

Public Report Period None

Chair James C. Roseman recognized and honored Vice Chair Larry Alexander for his years of dedicated service as Board Chair from 2014-2022. Vice Chair Alexander was presented with a plaque.

Chief Paul Buchter

Potential new Scott River Station Chief Buchter met with the regarding a station at Scott River Road and Tyler Gulch. The Merchants reviewed and approved the sample lease that Administrative Officer Salucci sent to them. Commissioner Williams has a 30'x30' unit she is willing to donate. It will need minor modifications. Chief Buchter will ask the Merchants for a specific list of their requirements for a heated storage unit. Utilizing the old Eastside Station (still in storage) slated to become the new Greenview Training Facility is not on the table for discussion as it is slated for installation in Greenview.

New Training Facility Progress Report Chief Buchter has completed the application with the surveyor, and it is ready to go to the Building and Planning Dept. All Building Dept fees are paid.

New rates submitted for engine & water tender strike team rates Chief Buchter has submitted rate increases for our engines and water tenders, justifying the increases with published inflation rates since 2015 and recent fuel increases which brings the increase to double our prior rates.

Resolution 04-14 passed agreeing to the stated increases. All ayes. No noes. Passed.

Chief Buchter also mentioned that both CalFire/OES and USFS are understaffed this fire season

Additions/deletions to roster, new firefighter applications Firefighter Jim Skelton asked to be removed from the roster due to health concerns.

Consolidation of SVFPD/EtnaFD/FJFD The second meeting of the year was recently held, and Chief Buchter stated everything is going well. Etna Ambulance was asked to join the conversation. They are also considering inviting Etna Police Dept to also join the conversation. This is currently a "fire and rescue alliance". Questions are on the table are about co-mingling funds and equipment to become a Community Service District. The three Chiefs are reviewing all three Standard Operating Procedures. All parties are collaborating with the consultant to get the foundation laid. The process will go through LAFCO with County Councilperson Dana Barton facilitating the process. Chief Buchter will reengage with Counselor Barton.
